### CONTRACT AND OBLIGATION AGREEMENT

**By signing this agreement, the OG Pass passholder agrees to abide by all Club policies and procedures, including those outlined below.** The Golf Club at Oxford Greens reserves the right to terminate without refund passholders deemed to be in violation of program terms and conditions and/or club rules and code of conduct.

**Conditions:** The OG Pass is valid for play Monday through Friday during the 2025 season. Free green fee access is subject to availability and course opening. Tee times may be required. Tournaments, events, and the following holidays are excluded: Memorial Day, Juneteenth, Independence Day, and Labor Day. Free green fee applies to PASSHOLDER only and may be subject to photo verification. Cart rental fees are not included; rental carts are required for play. Unused daily range buckets do not carry-forward to other periods, nor do they have any cash value for other redemption. From time to time, the range will be closed for maintenance and/or weather conditions. Range balls will not be dispensed during these periods. The Golf Club at Oxford Greens reserves the right to limit usage based on subsequent needs for other reservations throughout the day. Refunds, prorations, and passholder transfers are not available. The OG Pass Program may change without prior notice. The OG Pass will expire at the conclusion of the 2025 season.

**Golf Cart Rental Agreement:** In completing this purchase; I hereby agree to pay for any damages that are sustained to the golf cart I am renting, while in my possession, and assume all risk of operating the cart. I represent that I am familiar with the operation and use of said golf cart that I can operate and control same and will follow all cart operation rules. I promise and further agree to indemnify and hold lessor, its assignee and the golf course free and harmless from any damage or claims of any nature whatsoever that may arise from or through the use of said cart. I further agree to pay a \$100 charge to correct any tampering done to the golf cart while in my use in addition to any damages sustained per above.

Additionally, please note that service vehicles and beverage carts may operate against the flow of golf cart traffic for operational purposes.
